  - Office staff does NOT have access to tax records or related information
  - Direct all inquiries to the Tax Collector allowing 24-48 hour response time

## Pennsylvania is Building a World-Class 5G Network

The pandemic has shown that access to broadband highspeed connections is vital for our state to remain competitive in the global economy, educate our children and for the delivery of vital services, such as tele-medicine.

In 2021, Governor Wolf signed into law legislation that puts Pennsylvania at the forefront in building the latest 5G infrastructure. I was proud to work with Rep. Jim Marshall to co-author this measure.

More recently, the Governor signed into law a bill to improve access to high-speed internet in unserved and underserved communities across the Commonwealth by creating the Pennsylvania Broadband Development Authority (PBDA). I worked with the bill's House and Senate sponsors and Governor Wolf's office on this vital legislation.

Pennsylvania is guaranteed to receive at least \$100 million for broadband expansion and will have an opportunity to apply for a portion of an additional \$42.45 billion in Broadband Equity, Access and Deployment (BEAD) program funding.

The creation and expansion of highspeed internet infrastructure in Pennsylvania is vital. I will continue to work to improve this important resource for our communities.

## UPPER MACUNGIE TOWNSHIP IS PLEASED TO ANNOUNCE THE INITIATION OF THE TRAIL CONNECTIVITY & WALKABILITY STUDY

The study is the outgrowth of the 2019 Comprehensive Plan, A Plan for Growth Management and Preservation, which placed an emphasis on walkability and connections within our municipality. The plan states: "A lack of pedestrian and bicycle facilities with few transit routes connecting neighborhoods to schools, shopping centers, parks, recreation facilities, community centers, and employment centers impacts quality of life and limits travel within UMT to use of automobiles."

The study will produce a plan which will suggest a series of connectivity improvements to facilitate the safe, non-motorized movement of cyclists and pedestrians within and through the Township.

There will be a series of four (4) public meetings held over the next ten (10) months to gain the community's input for the plan. All public meetings will start at 7 PM at the following location:

Township Municipal Building 8330 Schantz Road | Breinigsville, PA 18031 Public meetings are scheduled for: Tuesday, Feb. 22 | Tuesday, May 31 Tuesday, Sept. 13 | Tuesday, Nov. 15

While in-person attendance is preferred you may also attend virtually. Please check the Township web page prior to the meeting date for instructions to attend virtually. Meeting minutes for each public meeting will be prepared and will be posted on the Township web site a week after the meeting.

There will also be a public opinion survey so that area residents can express opinions about the plan as well as an online interactive mapping tool to provide information to the trail planners. The opinion survey and the map will be available starting March 18th at the following internet addresses:

Simone Collins Landscape Architecture of Norristown, PA, was the consulting firm chosen by the Township for this project. They are joined by Spotts, Stevens & McCoy Engineers.

A 32-person Steering Committee will work with the consultants over the next ten months as an important part of the community participation for this initiative.

## COMPREHENSIVE PLAN PROJECT UPDATE

On October 3, 2019 the Board of Supervisors adopted Resolution #2019-50 which revised the Upper Macungie Township Comprehensive Plan.

The revised plan's purpose is to:

- Manage land use and shape the character, timing, and layout of future development.
- Preserve and conserve agricultural land, forests, historic landmarks, and cultural resources.
- Protect the environment and natural resources.
- Plan for the reliable supply of water.
- Meet the housing needs of present and future residents.
- Revitalize and enhance historic villages.
- Identify and implement transportation and capital improvements.
- Provide for community facilities, utilities, and services needed by a growing population.

The Plan balances its purpose with important community issues and implications related to traffic congestion, large-scale warehouse distribution, community connectivity, preservation and conservation of land, community character and sense of place, housing quality, choice and affordability and redevelopment of commercial and industrial properties.

These goals will be achieved through township ordinance amendments and adoption of new plans and studies. The Plan provides recommendations by listing action items or implementation items. The Implementation Plan can be found in the executive summary.

Since adoption of the Plan, UMT has passed legislation related to Code Compliance and 5G Small Wireless Facility regulation amendments which modernize the Township's Subdivision and Land Development Ordinance.

UMT has also awarded, by RFP, a contract for preparation of a Trail and Walkability Study which will consider additional regional connections.

Lastly, UMT continues to collaborate with LANTA, LVEDC, companies and employees to discuss needs & determine feasibility of bus service, stops & sidewalks during the SALDO process.

Draft Zoning Amendments are underway and are presently under review by the UMT Planning Commission. These amendments include;

- The addition of Agricultural and Resource Conservation Zoning Districts
- A proposed Mixed Use (residential/retail) Zoning Overlay District
- Revisions to the Light Industrial Districts to set levels of intensities and Industrial Buffer Zones
- The addition of the Community Development Goals and Objectives outlined within the Plan.

Remember that per the US Fire Administration, no matter the kind of detector, smoke detectors should be tested at least once a month. The batteries for the detector should be replaced, at a minimum, once or twice a year. The US Fire Administration also states that smoke detectors usually have a lifespan of 10 years.

## FIRE SPRINKLER SYSTEM

A fire sprinkler system is an active fire protection method, consisting of a water supply system, providing adequate pressure and flowrate to a water distribution piping system, onto which fire sprinklers are connected. Although historically only used in factories and large commercial buildings, systems for homes and small buildings are now available at a cost-effective price. Fire sprinkler systems are extensively used worldwide, with over 40 million sprinkler heads fitted each year. Even though Fire Sprinkler Systems are a Life Saving System and are not designed to protect the building, 96% of buildings that had fires and were completely protected by fire sprinkler systems were controlled by the fire sprinklers alone.

#### UMT's Live-In Program is Ideal for Young People Interested in Living Cost-Free While Serving the Community


Do you know any college students or young singles interested in **living cost-free** in a comfortable apartment while helping to serve our community as a part-time volunteer firefighter?

## THE SALDO UPDATE: WHY IT'S IMPORTANT WE UPDATE OUR ORDINANCES.

The Township updates its ordinances for several reasons. More often it is due to a change in State or Federal Laws such as stormwater or sewage facilities, a change in the Zoning Ordinance calls for an update in the SALDO, or the ordinance is outdated and needs updating to account for today's uses.

The Township recently updated several sections in its SALDO including, but not limited to, plan submission requirements, plan recording requirements, stormwater and impervious coverage requirements, and revised design standards for walkways and sidewalks.

## WHAT IS SALDO?



The Subdivision and Land Development Ordinance (SALDO) is the most common form of land use regulations in the Commonwealth of Pennsylvania. It sets standards and regulations for activities such as dividing land or making new lot lines (Subdivision) or improving the land for various purposes (Land Development). The Upper Macungie Township Subdivision and Land Development Ordinance can be found in Chapter 22 of the Municipal Code Book or at ecode360.com.

## Property Owners — Friendly Advice from the Code Office

Now that you have selected a project to do around the house and selected a contractor, what is the next step to properly start this project?

- 1. Is a permit required? Permits and inspections are required for all work subject to the PA UCC & UMT Ordinances. This includes, structural, electrical, plumbing, HVAC, decks, sheds, pools, patios, fences, walls, etc. Inspections are completed to make sure zoning/building codes are followed for placement & safety. Every permit needs an inspection of some type.
- 2. Did you know that the property owner is ultimately responsible for permits? When relying on a contractor to secure permits, make sure the permit is posted in your front window or door prior to allowing any work to take place. Before issuing a permit, our office will verify the contractor has the proper insurances and is qualified to do electrical/plumbing work.
- **3.** How do you know when a project is properly completed? A certificate of completion is issued by the Building Code Administrator for all UCC projects.

A new form, called "Important Notice to Property Owners", has been attached to all permits. This form makes the owner aware of their responsibilities under the code and requires their signature.

#### Always remember the 4P's – Proper Planning Prevents Problems!



### **ON-LOT SEPTIC TANK PUMPING UPDATE:**

#### **SEWAGE SYSTEM INSPECTIONS MANDATORY IN 2022 FOR DISTRICT 1 PROPERTIES**

This is an ordinance mandated by DEP to monitor the proper function of on-lot sewage systems to protect our water table and overall environment.



This directive is divided into three districts. The residents in District 3 met all requirements with no complications in 2021. District 1 property owners are required to have their septic systems cleaned and inspected by a registered pumper/hauler before December 31, 2022. A list of registered pumper/haulers can be found on our website, uppermac.org.

Scheduled maintenance of your on-lot septic system helps reduce high costs incurred by property owners should their septic system fail but ultimately protects and maintains a healthy environment for future generations.

## YARD WASTE REMOVAL GUIDELINES

For your convenience, Upper Macungie Township provides property owners with the means to properly dispose of their leaves and yard waste. We conduct curbside pickup twice a year in the spring (May) and the fall (October). www.uppermac.org/public-works/yard-waste-drop-off-site-information/

#### **CURBSIDE YARD WASTE PICKUP** PLEASE PUT YOUR YARD WASTE OUT THE NIGHT BEFORE THE PICKUP.

Semi-annually each year, there are fall (October) and spring (May) onetime curbside pickups of yard-waste for leaves from trees, garden residue, shrubbery trimmings, and tree trimmings. See restrictions below. Limbs and branches tied and bundled to a maximum of 48" x 18" x 18". If branches and limbs are not tied & bundled, they will not be picked up.

#### NO PLASTIC BAGS, STONES, LUMBER, GRASS CLIPPINGS OR ROOTS WILL BE COLLECTED!

Items improperly bagged or bundled will not be accepted. Leaf waste can be placed in open trash containers, no larger than 32 gallon capacity and less than 60 pounds. A combined maximum of six (6) bundles or containers per household will be collected.

#### IF YOU MISSED THE PICKUP DATE:

Yard waste may be deposited at the UMT Yard Waste Drop-off Site located near the intersection of Schantz & Grim Roads, next to the Public Works garage. Drop-off services is made available to **RESIDENTS ONLY**. Contractors and businesses are **NOT** permitted to use this facility.

Please remember that grass must be separated from other yard-waste. Shrubs and small trees accepted IF they are no longer than 4 feet long and 5 inches wide.

**The Township offers FREE mulch year-round** as a benefit to residents. During the month of May, Township staff will be available on weekends between 9am-1pm to help load.


