#### **Population Growth Imperatives Focus** of New Comprehensive Plan Update Project

In 2007 Upper Macungie Township developed a Comprehensive Plan to guide the management of our municipal and community resources through a coming decade of significant growth. That 2007 plan—based on the best data available at the time projected UMT population growth of 20,913 residents by 2020. But our population grew much faster than all projections. By 2010, UMT's population hit 20,063...almost as much as the 2007 plan called for, but happening a full decade sooner than projected.

To map out a future with the infrastructure and quality-of-life assets needed to meet this accelerated level of population growth, UMT's leadership has solicited proposals from highly-qualified professional planning consultants for a strategic 10-Year Comprehensive Plan Update.

Among the many factors making this Comprehensive Plan Update imperative are the latest UMT population growth projections from the Lehigh Valley Planning Commission (LVPC), shown below:

YEAR	UMT POPULATION	PERCENTAGE INCREASE
2020	24,992	22.6%
2030	30,232	40.6%
2040	36,235	53.5%





In addition to population, UMT has also experienced significant growth in existing and new warehouse/distribution centers, occurring in areas zoned as *Industrial*. These areas are located in the middle of the Township and have created the need for existing roads to be assessed for capability

> to meet the truck traffic volumes generated from the warehouses.

Much of the 2007 Comprehensive Plan remains relevant. The updated plan will draw on its framework and strategy to balance growth and development in relationship to UMT's public services, recreation opportunities, economic resources and natural amenities. Key focal points of the original Comprehensive Plan include:

- Preservation of open space, and park and recreational facilities
- Infrastructure in the form of a series of collector roads to accommodate future population growth and increased motor freight
- Diversification of land, use, building community character and quality development

Building on these points, but with the benefit of the current population projections, the new 10-Year Comprehensive Plan Update will provide valuable insights and guidance on:

- Broad land use policies
- Specific land use recommendations
- Implementation or "action" recommendations

October 3, 2016 is the deadline for submission of all proposals. The most qualified Planning Consultant will be determined by a Selection Committee comprised of Township Manager, Daniel Olpere, along with one member of the Planning Commission and two members of UMT's Board of Supervisors. Responsibilities of the chosen professional will include guiding the update process,

conducting public meetings to solicit input from residents and issuing recommendations to the Board of Supervisors.

To ensure the success of the new Comprehensive Plan Update, there will be multiple engagement opportunities for residents, property owners

and business owners. In addition, a Steering Committee will be formed from UMT resident volunteers who will be empowered to review the plan updates, and provide input and direction on UMT's long-term planning objectives. # BUREAU OF FIRE

This new UMT Department Spotlight feature will showcase one of the Township's departments and the services they provide to ensure the safety, health and quality-of-life for the citizens of Upper Macungie Township.

Few municipal services are more critical than protecting the lives of citizens from the ravages of fire. Here in Upper Macungie Township, that weighty responsibility is shouldered by our Bureau of Fire. Led by Fire Commissioner/Emergency Management Coordinator Grant Grim, the Bureau provides a very broad spectrum of functions critical to protecting our Township's families and properties. Among these are fire safety inspections, community education of fire prevention, grant writing, emergency services planning, coordination of safety management services with UMT and neighboring fire/police/EMS organizations, and much, much more.

Topping of this long list of duties is the leadership, resource allocation and management support the Bureau of Fire provides to the three all-volunteer fire companies within Upper Macungie Township: Good Will Fire Company #1 of Trexlertown Station #25, Fogelsville Fire Company Station #8 and Upper Macungie Township Station #56. Together with the Bureau, these volunteer fire departments respond to an estimated 1,500 emergency calls annually...on average, *more than* four emergency action responses every day (or night) throughout the year!

The full-time leadership, program coordination and management expertise the UMT Bureau of Fire provides is essential support for these three volunteer fire companies and the life-saving work they deliver year in and year out. It also helps save taxpayer dollars. Fire protection is a very expensive service proposition. Municipalities across the Lehigh Valley are seeing just how expensive. In 2015 the City of Easton had to replace a pumper truck and the price for that single firefighting vehicle was \$563,000, and costs are only getting higher. According to Ken Willette of the National Fire Protection Association, the price of

fire trucks has been increasing at a rate of 5 to 7 percent per year. Add in the costs for additional equipment needs, facilities, the costs of full-time professionals and the cost to provide fire protection services in a municipality the size of Upper Macungie Township would likely run into millions of taxpayer dollars annually. Thanks to our three all-volunteer fire companies—and the necessary management and support provided by our own Bureau of Fire—Upper Macungie Township citizens enjoy excellent fire protection services without the high costs paid by many other municipalities.

# UMT History: Schantz Spring

Every UMT resident knows Schantz Road...but how about Schantz Spring? Located near what is now Rt. 309 just west of I-78, for centuries the spring was a refreshing meeting place for our original residents, the native Americans of the Lenni Lenape tribe. The first white settler at the spring was John George Guth in 1744. It got its name from Jacob Schantz who acquired it in 1792; its waters powered his family's grain mill for half a century and was the power source for numerous mills along its run. According to a 1902 history the spring produced "pure water, being nearly free from mineral substances. The power and force of the spring is very remarkable." In 1901 it was sold to the City of Allentown and a pipeline was completed in 1903. Formerly an open reservoir, it is now "capped" but continues to produce 6 to 8 million gallons of pure water daily.

#### **RECYCLING & TRASH PICK UP GUIDELINES**

#### YARD WASTE COLLECTION

For your convenience, Upper Macungie Township provides property owners with the means to properly dispose of their leaves and yard wastes. There will be a one-time only, curbside pick up of YARD WASTE. After that, yard wastes may be deposited at the UMT Yard Waste Drop-off Site.

#### YARD WASTE CURBSIDE PICK UP

#### Wednesday, October 5, 2016

**WHAT:** Leaves from trees, bushes and other plants, shrubbery clippings and tree trimmings. (For maximum size, see "HOW TO PREPARE" below.)

WHAT NOT: No grass clippings, roots from trees or shrubs, or lumber. Improper bags, bundles or materials will go uncollected and tagged to notify residents of reasons why materials were not accepted.

HOW TO PREPARE: Yard wastes must be placed in commercially-designed open trash containers (with sloped sides) no larger than 32-gallon capacity with a loaded weight of less than 60 lbs. each. Smaller limbs and branches must be tied and properly bundled to a maximum size of 48" × 18" × 18" with a maximum weight of 60 lbs. If branches and limbs are not tied and bundled, they will not be picked up. Ties for bundles must be made of biodegradable materials.

All containers must be out the night before after 6 p.m.

**HOW MUCH:** Combined maximum of 6 containers will be collected.

#### **HOLIDAY TRASH PICK UP**

PLEASE NOTE – The service is one day delayed for Thanksgiving Day:

Thursday pick up will be **Friday**, **Nov. 25** Friday pick up will be **Saturday**, **Nov. 26** 

Please place your trash cart out for collection the night before your pick up day at curb or grass area several feet away from the mailbox, landscaping, or telephone poles. It should NOT BE PLACED ON THE STREET. Your recycle bin can be placed several feet from the cart. As a reminder, any trash placed outside your cart, or not in a UMT trash cart, will not be collected. You can purchase another cart for \$55. There is no extra trash fee. Residents are allowed to have a maximum of two 95 gallon carts.

WASTE MANAGEMENT is the service provider to handle refuse and recycling collection in Upper Macungie Township. Refuse and recycling pick up is on a weekly basis. New residents: you must come into the Township building to fill out a moving permit. You will then be informed when your trash cart will be delivered (for new construction only), which zone you are in for trash pick up, and what day your pick up will be.

# CARDBOARD RECYCLING CONTAINERS

Upper Macungie Township has 2 containers for recycling CARDBOARD which are for UMT Residents Only.

- UMT municipal building parking lot drop-off site: Monday – Friday, 7:30 a.m. - 4 p.m.
- UMT yard waste site on Grim Road: Monday – Friday, 3 - 7 p.m. Saturday/Sunday, 9 a.m. - 5 p.m.

Both sites are closed on holidays. This does not eliminate cardboard recycling at the curbside. It is for the times when it rains or you have a lot of cardboard. You can bring the flattened cardboard to UMT and put it into the recycling containers.

#### LEAF COLLECTION SCHEDULE



The Upper Macungie Township Department of Public Works will begin its annual Leaf Collection Program on Monday, October 10. The crews will cover the entire Township three times. Due to the rate of maturity of trees within the Township, and also the fact that more trees are planted every year, it is impossible to guarantee a set pick up day for a specific street in any area.

All residents in the Township should place their leaves along the edge of the road, not on the road, prior to the start of pick up at 7 a.m. on Monday of each week. Leaves will normally be picked up between the hours of 7 a.m. to 3 p.m., Monday through Friday. Leaves will not be collected on private property. If leaves are not in place when the crews go by, they will be picked up on the following round through the Township. No "return trips" will be made to pick them up.

- Do not place pieces of wood, steel, rocks or concrete on the leaves to hold them down. These objects will cause extensive damage to the leaf pick up units and put them out of service at a great expense of time and money to the Township and its citizens.
- To pick up leaves by mechanical means, it is necessary to dump the contents of plastic bags or other containers into the gutter area. Crews will not empty bags or other containers; this is the responsibility of the resident. Branches, shrubbery, garbage, and building materials will not be picked up. These items will be left behind and it will be the responsibility of the resident for removal and disposal.
- To facilitate the picking up of the leaves, please keep all vehicles away from the area where the leaves are piled. The crews will not rake piles of leaves out from between parked cars or from under them.

#### **RAINSTORM READY:**

UMT in Infrastructure Initiative for Cleaner, Healthier Water Resources

There are many ways Upper Macungie Township is working to keep our streams clean. The newest initiative is a team effort with our neighboring municipalities called "Rainstorm Ready." Here's why we need it:



Every municipality's sanitary sewer lines are engineered to transport just that: sewage. (UMT alone has more than 100 miles of sewer lines!) Regional sewer lines all lead to the Allentown treatment plant for processing. But heavy rains--or illegal sump pumps—can seep in and seriously overload these lines and the treatment plant's processing capacity. Extra flow must then be released into waterways. Not good.

It's a regional problem that requires a regional solution. UMT and six neighboring municipalities have teamed with Lehigh County Authority to form the Western Lehigh Sewerage Partnership (WLSP). Infrastructure improvements for regional pumping stations, parallel sewer interceptors, flow equalization tanks and other upgrades will help prevent sewage overflow.

It's a big job that will take eight years and \$50 million shared by all the municipal partners. But it has to be done to keep our precious water resources clean and healthy for today's families...and future generations. To find out more and how you can help, visit www.rainstormready.com.



#### **RAIN GARDENS:**

Natural Solution for Runoff Pollution

As communities grow, so do impermeable surface areas which keep rainwater from soaking back into the nearby soil.

Driveways, homes, schools, retail centers, parking lots—many elements which enhance the quality of life here in Upper Macungie Township also turn rain into runoff. Heavy rains produce "stormwater superhighways" which pick up multiple pollutants before emptying into the closest streams or other bodies of water.

Rain gardens are landscaped depressions designed to capture and naturally infiltrate rainwater back into the earth. They are hailed as a Best Management Practice solution to runoff pollution and UMT has made them a storm water permit requirement for many new home developments.

It is the homeowner's responsibility to maintain a rain garden or other storm water management feature on your property. Like any landscaping activity, this can be a labor of love with beautiful results. Maintenance consists mostly of mulching (great for water filtration), weeding, replacing dead vegetation as needed and watering during dry conditions to keep plants healthy.

Don't have a Rain Garden now? With wild flowers, ornamental grasses and other features, a Rain Garden can add visual value to your property while providing a natural solution to runoff pollution. **UMT** Program Shapes a Future for "Future Firefighters" and "Police Cadets"

Conducted annually, the Junior Emergency Services Academy provides a unique summer opportunity for UMT youngsters—ages 12 to 16—to learn basic skills required for a future in emergency services. UMT's Bureau of Fire teams with our UMT Police Department, Cetronia Ambulance Corps and Macungie Ambulance Corps in the week-long educational experience focused on basic firefighting and police training.

Twenty-nine students earned certification in Heartsaver CPR/AED and first aid, along with key firefighting skills—hose line advancement and stream application. A new "twist" for this year's curriculum was knot-tying for specific uses in various fire scenarios. A special guest appearance was made by arson-detecting canine "Judge" courtesy of Fire Chief Lee Laubach of the Allentown Fire Department.

In addition to learning valuable fire training skills, cadets also received two days worth of police training, which included traffic stops, DUI awareness and hostage negotiations.

Capping the final day was a skills challenge where our "future firefighters" and "police cadets" got to put their new skills into practice, followed by a picnic for all students, their families and academy educators. Special thanks to all parents who assisted our staff in preparing the food for this capstone celebration. This program has grown in popularity through the years and the 2016 session was a huge success with many students returning for their second and even third year to further their lifesaving skills.

#### SPOTTED LANTERNFLY

#### **FACTS:**

The **Spotted Lanternfly** was first discovered in 2014 in eastern Berks County, and it has become a major pest. This plant-hopper will feed on trees and many other host plants including grapes, apples, and stone fruits. The adult size is approximately 1-inch long and 1/2-inch wide at rest.

Early detection of the Spotted Lanternfly is vital to prevent this invasive insect from spreading to local businesses and agriculture, such as vineyards in Upper Macungie Township.

#### **ACTION:**

If you find **any** life stage of the Spotted Lanternfly, remove the insect or scrape off egg masses, devitalize, place in a sealed bag, and dispose of bag in the garbage. Check your outdoor items before you move them.
