
Q1 Are you a resident of Upper Macungie Township?



Q2 In what age range do the heads of your household fall? CLICK ALL that apply



To build a Community Center with amenities on the Wish List by means of the lowest possible financial impact to residents, construction would be broken into Phases. The Township would use developer recreation fees, relevant grants, budget money, and explore potential donations or sponsorships to fund the phases. Completion would be dependent on funding.
