BOARD OF SUPERVISORS

The monthly meeting of the Board of Supervisors of Upper Macungie Township was held on December 6, 2012, in the Municipal Building at 7:00 P.M. Those present were Chairman Edward J. Earley, Vice-Chairman Samir P. Ashmar, Secretary Kathy A. Rader, Solicitor Andrew Schantz, Township Engineers Dean Haas and Scott Stenroos, Treasurer Barry Moyer, DPW Scott Faust, DCD Ken Molony, Fire Commissioner Grant Grim, Chief Edgardo Colon and Assistant Secretary Owen M. Bastian.

Chairman Edward J. Earley opened the meeting and asked all present to join him in the Pledge of Allegiance to the flag of the United States.

Chairman Earley stated that the minutes of the previous meeting would not be read unless there was some objection. Vice-Chairman Ashmar had two corrections, the first under his report - The recent Hurricane has shown the need for emergency generators at various Township facilities in the Township. Upon a motion by Vice-Chairman Ashmar, seconded by Chairman Earley and unanimously approved the purchase and installation of generators for the three fire stations and the UMT Municipal Building will be made. The costs for any upgrades to come out of the capital reserve fund. Township resident, James Brunell, has offered assistance regarding the size analysis for each generator at the four buildings. Amendment made to minutes at the December 6, 2012, Board of Supervisors meeting.)

The second correction is under Treasurer Moyer's Budget report. The following is to be added: Several companies within the two townships have expressed interest in corporate contributions. \$50,000 is to be allocated for a portion of said command vehicle in the 2013 Budget. Resident Shohn Montano told of a command vehicle at Lehigh Valley Hospital. It was decided that the Board would take a look at that vehicle.

Upon motion by Chairman Edward J. Earley, seconded by Vice-Chairman Samir P. Ashmar and unanimously approved it was agreed to dispense with the reading of the minutes of the previous meetings. The minutes of the previous meetings are approved as amended.

Chairman Earley presented the bills for the month of November totaling General Fund \$1,730,008.15 and Sewer Fund \$85,981.65. Upon motion by Chairman Earley, seconded by Secretary Rader and unanimously approved, Treasurer Moyer is authorized to pay the General Fund bills for the month of November in the amount of General Fund \$1,730,008.15 and Sewer Fund \$85,981.65 Mr. Jim Burnell questioned the high bills. Treasurer Moyer explained that two major road projects were completed and the Police building was completed. V-C Ashmar explained that all three Supervisors review the bills before they are approved for payment.

RECREATION BOARD -

Secretary Rader reviewed the Recreation Board report. Copies of the complete report are available on the table in the back of the room. V-C Ashmar and Engineer Haas reported that a grant has been applied for to place a water fountain for people and dogs in the dog park.

KCE has done a study that shows trucks should be prohibited due to inadequate road width for large vehicles. Upon a motion by Secretary Rader, seconded by Vice-Chairman Ashmar and unanimously approved it is RESOLVED that ORDINANCE #2012-07, "AN ORDINANCE OF THE TOWNSHIP OF UPPER MACUNGIE, LEHIGH COUNTY, PENNSYLVANIA, AMENDING CHAPTER 15 (MOTOR VEHICLES AND TRAFFIC), PART 2 (TRAFFIC REGULATIONS) OF THE CODE OF ORDINANCES OF THE TOWNSHIP OF UPPER MACUNGIE, AMENDING NO TRUCK TRAFFIC ON CERTAIN STREETS LOCATED WITHIN UPPER MACUNGIE TOWNSHIP; SAID REQUIREMENTS BEING SET FORTH MORE FULLY IN THE BODY OF THIS ORDINANCE" be and is hereby adopted by the Board of Supervisors of Upper Macungie Township.

Ordinance #2012-08 - Modifying Charges for Sewer Rental

Upon a motion by Chairman Earley, seconded by Vice-Chairman Ashmar and unanimously approved it is RESOLVED that Ordinance #2012-9 "AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF UPPER MACUNGIE, LEHIGH COUNTY, PENNSYLVANIA, AMENDING CHAPTER 20 OF THE CODE OF ORDINANCES OF UPPER MACUNGIE, PART 2, SECTION 209 MODIFYING CHARGES FOR RESIDENTIAL MUNICIPAL SOLID WASTE WITHIN THE TOWNSHIP AS MORE FULY SET FORTH IN THE BODY OF THIS ORDINANCE" be and is hereby adopted by the Board of Supervisors of Upper Macungie Township.

Upon motion by Secretary Rader, seconded by Chairman Earley and unanimously approved it is RESOLVED that Resolution # "A RESOLUTION OF UPPER MACUNGIE TOWNSHIP AUTHORIZING THE AMENDMENT AND RESTATEMENT OF ITS PREMIUM ONLY PLAN" be and is hereby adopted by the Board of Supervisors of Upper Macungie Township.

Traffic Engineer Stenroos reports that the signs have been installed.

Woodmont - KRE Group - Conservation Design/Apartments

Previously a petition was received by the Board of Supervisors from the Woodmont Group requesting that the Township amend the maximum height, number of units per building and maximum size of building for apartments. The Supervisors passed this on to the Planning Commission and staff to consider the request. The Planning Commission and staff considered this should be an amendment to the Conservation Design Ordinance which would provide the same overall density on a smaller portion of land where environmentally sensitive lands exist. Engineer Haas, Solicitor Schantz, and DCD Molony have drafted said amendment to the conservation Design Ordinance for apartments with height, number of units and size providing more building density in return for more conservation preservation. Attorney James Preston appeared on behalf of Woodmont and questioned some of the proposed changes to the separation of units. These were approved by the Board to be revised, as presented. Upon a motion by Secretary Rader, seconded by Chairman Earley and unanimously approved, the proposed changes to the Conservation Design Ordinance, as amended at this meeting, are to be referred to the UMT Planning Commission and the Lehigh Valley Planning Commission for review and comment.

Park Rule Question

Vice-Chairman Ashmar suggested a minor park rule change. Upon a motion by Vice-Chairman Ashmar, seconded by Secretary Rader and unanimously approved Park Rule concerning hand guns is hereby modified to read only that to discharge weapons is hereby prohibited.

January Board of Supervisors Meeting Change

The 2nd Class Township Code requires all Townships to meet the first Monday in January to re-organize for the new year. Upon a motion by Secretary Rader, seconded by Chairman Earley and unanimously approved January 7th at 7 P.M. was set as the date for the annual re-organization meeting with the regular monthly meeting to follow.

The new adjusted rate for the Township is .64 mill. It should raise the same revenue as the previous rate. Fire hydrant purposes, the sum of .10 mil on each dollar of assessed valuation.

For general purposes the following local tax enabling taxes: real estate transfer one-half percent; earned income tax one-half percent; that any resolution or part resolution, conflicting with this resolution be and the same is hereby repealed.

Enacted on November 29, 2007 a local service tax of forty-seven (47.00) for the privilege of engaging in an occupation within the Township of Upper Macungie, providing definitions of said tax, providing exemptions from the tax, establishing collection procedures and establishing penalties for violation of these regulations, in accordance with Pennsylvania Act 7 of 2007.
