

The Reorganization Meeting of the Board of Supervisors of Upper Macungie Township was called to order on January 3, 2022 at 6:30 p.m. in the Municipal Building, 8330 Schantz Road, Breinigsville, PA 18031. Motion by Chairman Brunell to accept the Consent Agenda as presented. Seconded by Supervisor Rader. The motion passed unanimously.

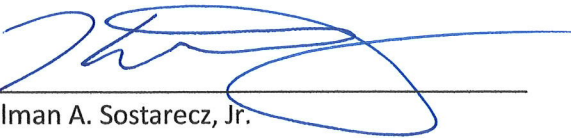
