New Business

- Community Center Public Meeting Dean will give presentation around studies done and actions completed to date. Focus will be on budget, as township has indicated that they will not raise taxes. There is \$1-3M earmarked, but the project estimate is \$15-\$20M. There is concern that, because of the article that was published, many attendees will be opposed to the cost. People seem to be looking for more concrete plans around how the community center will be self-sustaining. We should highlight the possibility of a capital campaign and what impact that may have on the cost to the township; highlight what surrounding communities have done. Should highlight that the previous 10-year recreation plan was primarily funded by developer fees and grants. Lynn and Dean will provide handouts with bullet points around the options, potential amenities, and costs. Bob, Dean, Howard/Eric, Bruce will be doing most of the speaking. Dean indicated other recreation projects are still earmarked for the budget separate from the recreation fund. We should highlight the growth of the community, and expectations of new families moving into the area. Price estimates were based on recently constructed facilities. Recommend providing specific scenarios and possibilities of what the facility could be like. Dave asked if there has been coordination with Jaindl regarding logistics/setup. Bret questioned if there is data highlighting the impact of recreation centers on property values (study says increase).
- **Friends Donation Projects** Need to identify projects for donations. Katie identified that there is earmarked money for projects already, will send to board/Lynn.
- Pickleball Clinic Andrea Jones (ambassador for Pickleball) would like to do some free clinics (after May 15) – kids/adult clinic. Would likely be at Blue Barn. She would need clearances to have a kids clinic. Bret suggested we wait until clearances are obtained before we vote; will be discussed at an upcoming meeting.
- **Tree Donation** need more information from Sean; Jason said a proposed plan was provided on potential locations (Grange).
- Giveaways, display purchases Pens, drawstring bags, cell phone stands, microfiber cloths.
 Lynn is also looking for a better table cloth and banner for events. Need to let Lynn know if we
 want township to purchase items, or if we want to donate from Friends. Lynn will also send
 proposed t-shirt design to board.
