We will specify the location to be in the Northeast corner of the park near the proposed Recreation Center site, approx. 420ft x 85ft. Andrew suggested adding language that identifies the examples of what is included. "Foodstuffs" is one word – definition: a substance used or capable of being used as nutriment. We will also include "direct marketing sales/network marketing sales" with examples. We will also specify that community programming is permitted as long as there is no additional cost to the community.

- New Recreational programs follow up:
 - o Safe Sitter approved. Lynn is working with Delia to set dates. We will promote.
 - DIY Workshops (info previously emailed to board) still working to get additional information on this; would like to understand what is most popular, what is recommended, and what the pricing would be
- Bylaws update Need to make sure they are closely followed. Motions and names should have names attached. Bylaw amendments require roll-call vote with all being present. Bret commented that we should be more specific with "good cause" absences and stress the importance of regular attendance. We need to find out from Bob Ibach what the appropriate options are for by-laws voting. If an issue comes to the BOS that is overly complicated, or there are questions on, it will be tabled until the next month so there is time for review. Andrea suggested that a supervisor should be in attendance to minimize confusion. Lynn will ask Bob Ibach if email is appropriate for roll-call vote.
- Friends Donation Projects/Structure Lynn is working with Chuck to get a meeting set up. Chuck needs to call reorganizational meeting, need to vote on chairperson (and other roles), need to review/reapprove by-laws (all current members must be presents). Jim Brunell, Kathy Rader, Chuck Thomas, April Navarro are current members.
- Giveaways, display purchases –Need to let Lynn know if we want township to purchase items, or if we want to donate from Friends. Lynn will also send proposed t-shirt design to board. – carried over from last meeting
- **Tree Donation** no discussion need more information from Sean. carried over from last meeting

Bret motioned to approve Convergent to manage the Capital Campaign Feasibility Study, and assuming a positive result, continued support to manage the Capital Campaign; Karla seconded.
