UPPER MACUNGIE TOWNSHIP PARKS AND RECREATION BOARD Monthly Meeting Minutes August 2018

The monthly meeting for the Upper Macungie Township Recreation Board was held on August 16, 2018 at the Upper Macungie Township Building. The following Recreation Board members were present: Karla Trumbauer, Bret Spangler, Andrea Russell, April Navarra, Matthew Bernard. The meeting was called to order at 7:09 PM by Andrea Russell. She invited all present to join her in the Pledge of Allegiance.

MINUTES

Bret motioned to approve the July minutes, Andrea seconded – all approved.

PUBLIC COMMENT

Introductions of all attendees were done for the benefit of guests and new board members. April raised the point about bike trails, and there was discussion that this was discussed during the township planning meeting. Lynn mentioned there may be some grant money available specifically to connect trails.

Dave Keppel/Steve Walck were invited to improve coordination between the Rec Board and PSD. Dave spoke about the new elementary school, which is intended to be a "community school" with a lot of usable space for activities and sports. The school is specifically be designed so community spaces (gym, cafeteria) can be used by the community outside of school hours. Ground breaking was today, with construction completing spring of 2020.

Steve coordinates all activities with outside groups using the facilities. For scheduling any of the facilities, we should contact Steve. He will then send a Facilities Usage Request form back and will check for availability and certificates of insurance (Certificate of insurance is required for every request). We would need to identify a main contact point for all activities in cases of inclement weather or emergencies. Custodians are in the buildings until 11pm Mon-Fri, and in winter months on Saturdays until 4pm. Regarding insurance, Lynn can help coordinate – the school district ends up being named as an insured party.

Dave asked if we run summer camps and could potentially utilize schools for those or any programs we may need a facility. He also indicated that if there is ever a grounds issue or something needs to be addressed at one of the schools, we should just contact him or Steve. Steve will verify that everything is taken care of for fall volleyball and basketball.
