#2236 Proposed revisions to Zoning Amendment to permit farm-based entertainment (Agritainment/Agritourism)

Andrew Schantz opened the discussion on this ordinance by presenting an overview of the events that have taken place thus far related to this amendment and advised that the discussion be limited to the revisions made by the Board of Supervisors. After some discussion, P. McNemar made a motion that the setback for haunted activities be increased from 100 to 300 feet from the property line. K. Snelling seconded. Motion passed (vote was unanimous).

- P. McNemar made a motion that "nonmetallic" should be changed to "rock or concrete" and "noise suppressor" should be changed to "sound muffling devices" with respect to the section on air or propane cannons. C. Walls seconded. Motion passed (vote was unanimous).
- P. McNemar made a motion to add to the ordinance the approved use of air or propane cannons. C. Deprill seconded. Motion passed (vote was unanimous).
- P. McNemar made a motion to increase the setback for air or propane cannons to 500 feet. C. Walls seconded. Motion passed (vote was unanimous).
