2023 Recreation Department General Update:

The Recreation Department is working to put together a comprehensive Spring/Summer 2023 program and event schedule for the community. All forms have been updated to reflect the new streamlined process. The Department continues to encourage residents to utilize our online software, RecDesk, for all rentals and registrations.

10 Year Capital Improvement Plan

Staff has drafted a 10-year capital improvement plan and will be working with the Parks and Recreation Board and Public Works Department to finalize this plan in 2023. This document will then be incorporated into the upcoming Park, Recreation and Open Space Plan which we hope to accomplish in 2024.

Marketing:

The Recreation Department continues to update the new website to make it aesthetically pleasing and easy to use for residents. In addition, the Township's 2023 Spring/Summer newsletter is currently being designed and RecDesk is being updated as we prepare for 2023.

Department of Conservation and Natural Resources (DCNR):

Department staff met with our DCNR regional advisor to discuss potential 2023 grant applications. Staff also met with the DCNR Forester and will be applying for a grant through the Bare Root Tree Program to secure additional trees for Grange Park.
