PLANNING REVIEWS COMPLETED FOR MAY PC MEETING 2024:

Docket #2344–Americold Expansion–7150 Ambassador Drive, Final Land Development Plan–The applicant is proposing an expansion of their existing facility by 326,842 square feet along with associated site improvements such as parking and stormwater facilities. The site is located within the Township's LI–Light Industrial Parking Zoning District. This plan received recommendation for Final plan approval.

Docket #2374–110 PA Route 100 Manufacturing Building, Preliminary Land Development, 110 PA Route 100–The applicant is proposing the construction of a 150,400 square foot manufacturing building and associated site improvements including parking and stormwater facilities. The project is located within the Township's LI–Light Industrial Zoning District. This project was tabled by the Planning Commission.

Docket #2338–Twin Ponds, Preliminary/Final Land Development, 8739 Hamilton Blvd, the applicant is proposing to construct 132 residential apartment units within 22 buildings and a daycare facility utilizing the Township's Mixed-Use Zoning Overlay. The project is located within the Township's NC–Neighborhood Commercial Zoning District. This project received Preliminary/Final plan recommendation.

Docket #2363–EasternLift Truck Building Addition, Preliminary/Final Land Development, 7050 Snowdrift Road, the applicant is proposing construction of a 29,800 square foot addition to their existing facility and associated site improvements including parking, sidewalks, and stormwater management facilities. The project is located within the Township's LI–Light Industrial Zoning District. This project was tabled by the Planning Commission.

GRANGE ROAD ROUNDABOUT:

Construction of the Grange Road roundabout will be starting in June awaiting final schedule from contractor for official start date. Temporary traffic signals will be in place to assist with traffic control during construction. Additionally, a temporary access drive into Grange Road park from Grange Road has been constructed due to the necessary closure of the main park driveway during construction.

2024 Recreation Department General Update:

- Staff recently finalized the contract agreement with Simone Collins and will be starting progress on the Comprehensive Recreations, Parks, and Open Space Plan shortly.
- Playground equipment for the Russett Park capital project has been ordered and staff are working to schedule an installation date with a target completion of August 2024. The final color selection of the playground equipment was determined by a public poll.

On May 3, 2024 Officer Riley Miller completed DRE training which included over two-weeks (72 classroom hours) in physiology, vital signs, standardized field sobriety testing (SFST), as well as extensive instruction on each of the seven (7) drug categories in the DECP. The Drug Evaluation and Classification Program (DECP) focuses on training police officers to recognize when an individual has been driving under the influence of drugs and to identify the type of drug causing impairment. Upon completion of their initial training, officers are certified as Drug Recognition Experts (DREs) and become far more effective in identifying drug impaired individuals.

On May 19th and 20th, Officer Michael Holtz and Officer Julia Poapst presented to new lifeguards at the Applewood community pool. They discussed the 911 system and answered any questions they had.
