# PLANNING REVIEWS COMPLETED FOR JUNE PC MEETING 2024:

**Docket #2356 - Parkland Circle, 6045 Reppert Lane,** Preliminary Land Development – the applicant is proposing the construction of 25 townhome units at 6045 Reppert Lane. The project is located within the Township's R5 – Medium High Density Residential Zoning District. B. No action was taken and the plan was tabled.

**Docket #2343 121 Nestle Way & 8361 Schantz Road**, Sketch Plan – the plan proposes the development of an 82,167 sq. ft. warehouse, associated parking, stormwater facilities, and other associated site improvements. The proposed plan is located within the Township's LI – Light Industrial Zoning District. C. No Action was taken

**Docket #2048B – Mosser Road Residential Subdivision – 1050 Mosser Road,** Revised Final Land Development Plan – The applicant is proposing to revise the recorded plan to show increases in the impervious coverage to account for larger units and future amenities for the 10-unit single family development. The project is located within the Township's R-3, Medium Low Residential Zoning District. D. This plan was recommended for approval of the revised final plans.

**Docket #2355 TransEdge Truck Centers, 5344 Tilghman Street,** Preliminary/Final Land Development Plan – The applicant is proposing to demolish the existing northern-most building and construct a new 33,075 square foot building in its place, along with dedicated tractor parking spaces and employee parking areas. The site is located within the Township's HC – Highway Commercial Zoning District. E. This plan was recommended for preliminary plan approval.

**Docket #2334 BlueTriton Semi-Trailer Entrance, 405 Nestle Way,** Preliminary/Final Land Development – the application is proposing modifications to the access road around the site. Improvements on the site include, widening of internal roadways, reconfiguring internal traffic patterns, and improving an abandoned roadway (Previously Fogel Road). The project is located within the Township's LI -Light Industrial Zoning District. No action was taken and the plan was tabled.

# GRANGE ROAD ROUNDABOUT:

Construction of the Grange Road roundabout will be starting on July 15th. Temporary traffic signals will be in place to assist with traffic control during construction. Additionally, a temporary access drive into Grange Road park from Grange Road has been constructed due to the necessary closure of the main park driveway during construction. Please anticipate construction delays in this area. The

secondary driveway location at Auburn Drive will also remain open to the park. It is anticipated for the main construction to be completed by the end of August.

# **ARLE GRANT:**

A grant was submitted for the Automated Red Light Enforcement grant with PennDOT to upgrade the signal detection equipment at 13 intersections in UMT. If awarded this project will convert the inground detection loops to either camera or radar detection. Upgrading the traffic signal detection equipment will enhance safety and help improve the efficiency, reduce maintenance costs, and improve the reliability of the traffic management systems.
