**The Upper Macungie Township Zoning Hearing Board will hold a public hearing on Wednesday August 14<sup>th</sup>, 2024, at 6:30 P.M., at the Upper Macungie Township Municipal Building, 8330 Schantz Road, Breinigsville, PA 18031 to hear the following applications:**

**#01 24 001** The application of Thind Realty, LLC, 8942 Pathfinder Road Breinigsville, PA 18031; for:

1. An appeal of the Zoning Officer's decision dated October 6, 2023, which denied the Use Review & Business Occupancy Application of Central Truck Repair, Inc. to maintain, repair and store vehicles and equipment on property located at 832-840 Trexlertown Road Breinigsville, PA 18031 on the basis that: (a) Such use is permitted by right under Section 27-306 of the Upper Macungie Township Zoning Code; (b) Such use is a continuation of a lawful non-conforming use under Section 27-806 of the Upper Macungie Township Zoning Code; (c) Such use is permitted by right and may not be precluded under Pennsylvania law pursuant to the doctrines of estoppel, vested right and/or variance by estoppel; (d) Applicant is not required to meet Sections 27-402.G.(7) and 27-402.NNN of the Upper Macungie Township Zoning Code; and (e) Applicant meets the minimum lot area requirement of the LI Zoning District as set forth in Section 27-307 of the Upper Macungie Township Zoning Code.
2. Or in the alternative: (a) A variance from Sections 27-402.G.(7) and 27-402.NNN of the Upper Macungie Township Zoning Code, which require three (3) acres for the Applicant's requested use; and (b) A variance from Section 27-307 of the Upper Macungie Township Zoning Code relating to the minimum lot area of 87,000 square feet for parcels in the LI Zoning District.
